Since my practice is nation-wide, I really enjoy getting to meet attorneys from all across the U.S. at WEM. I am also looking forward to visiting my sister in Greece. She studied abroad in Athens this past semester, so I'm really excited to see her and visit Santorini and Milos together.

Share any other information about yourself that you think our readers would enjoy.

Toward the end of my tenure at my first job, I was asked to help with a presentation to an institutional client regarding the opioid epidemic. Researching the opioid epidemic and learning about the pharmaceutical industry really sparked an interest... I could not believe how much influence pharmaceutical companies have over the U.S. healthcare system. At the time that I was assigned this presentation project, I knew that I wanted to take my career in a different direction, but I was not sure what I wanted to do. Little did I know at that time, this presentation project gave me an answer. Two months later, I began a new job as a plaintiff's mass tort attorney where I bring cases against pharmaceutical companies for negligent and intentional wrongful conduct. Life has a funny way of working things out sometimes, and I am so happy to have found a line of work that I am passionate about (p.s. if you have not watched "Dopesick" on Hulu yet, I highly recommend you add it to your list!).





Covid Attorney

You have likely heard the term "COVID bride" develop out of this pandemic over the past 2 years, but what about "COVID attorney?" I had the honor of being both, and I want to share my experience about the latter. I was sworn into the Illinois Bar in November 2019, just a few months before the world shut down and our entire profession experienced a new way of practicing law. Just as brides dealt with unique experiences in planning their weddings during a global pandemic, attorneys who began practicing around the time I did have also had a unique experience beginning their legal careers.

As a new(er) member of the Advocates Society, I'd like to briefly introduce myself and share a little bit about my experience as a "COVID attorney." I began my career as a medical malpractice defense attorney and that job provided me with great courtroom exposure – I had the opportunity to attend case management conferences daily as well as motion hearings for about four months before the world came to a halt. When COVID-19 hit Chicago in March of 2020, my career seemed to have changed overnight. I went from being at the Daley Center every single day to sitting at my computer at home for endless hours and countless days. A year later, in March of 2021, I decided to change pace and began practicing plaintiff's mass torts (product liability personal injury cases). Two and a half years into my practice, as the world seems to slowly return to pre-pandemic ways, I have been reflecting on my almost exclusively remote practice as I began my legal career at the start of a global pandemic.

A significant part of learning to practice law comes from the help of other caring, experienced attorneys. Law school does not necessarily teach you how to work up a case in active litigation, to take a deposition, or to develop business. Yet, those are some of the most important aspects of building a successful practice. Young associates learn much of this through collaboration with other attorneys – other attorneys at their firm, attorneys we meet at networking events, attorneys we meet in court and at depositions... attorneys we meet through the daily practice of law as it existed pre-pandemic. Once the pandemic arrived, everyone was forced to socially distance and those opportunities to interact with and learn from other attorneys diminished. I feel like I lost out on learning occasions and professional growth by encountering the pandemic right at the start of my legal career. Law school engraved in my head how important networking is and yet it was really difficult to form and nurture professional relationships when social contact came to a lull. Like many others, I had to adjust to a very isolated version of law practice but without a foundation of knowing how to navigate the practice.

I know that the practice of law is a continuous learning curve and I have a long way to go, but I feel more confident each and every day as I improve on my skills in litigating my cases and advocating for my clients. While the pandemic slowed down that growth, I am very fortunate to have found my fit at a firm and to be surrounded by seasoned attorneys who care and have a positive impact on my career development and growth. My job and my involvement with bar associations is helping me catch up on what I lost out on in the past 2 years, so I am extremely excited to be a part of this wonderful community of attorneys who support Polish American culture and heritage. I look forward to connecting with you all at future Advocate events!

Fun Facts about Poland's History

Since Poland recently celebrated its national constitution day on May 3rd, this is the perfect time to discuss some interesting facts about Poland's constitution and national history.

Poland's constitution was only the second written constitution in the world. It was adopted on May 3, 1791, only four years after the American Constitution. Unfortunately, the Polish Constitution only lasted for 14 months as Poland was partitioned by Russia, Prussia and Austria. Poland was not on the map for 123 years, until after World War II. Fortunately, Poland has survived all of that.

Originally, Poland was named after an ancient Slavic Tribe. The name comes from the Western Slavic tribe, "Polanie," which means "people living in open fields." This tribe inhabited the region starting in the 6th Century. The national colors of Poland are red and white. The red and white were the national colors of Poland since 1831. The color red represents love, sacrifice and bravery. The color white represents goodness and purity of intentions.



Poland has the second oldest University in Europe. The Jagiellonian University was founded by King Casimir III the Great in 1364. The first university in Europe was in Prague 16 years prior. The Jagiellonian University still has its doors open and is one of the most prestigious universities in Europe today. 
Chicago Park Renamed After Polish Poet, Writer Gertrud Kolmar

Advocates member **Mark Dobrzycki** is part of a group of people including Daniel Pogorzelski and Michał Niemkiewicz of Chicago's Polonia who worked together to successfully petition the Chicago Park District to rededicate an existing park in Chicago's Old Irving Park neighborhood in honor of a poet who was a victim of the WWII Holocaust. The group brainstormed to develop a plan of action to have the park named in honor of noted poet and writer Gertrud Kolmar.

Mark along with the other members of the committee were able to convince the CPD Board through strong support of community organizations and others including Paul Chodziesner, the only surviving relative of the poet, that the change in the dedication of the park was most appropriate. From Chicago's Polish Museum of America to DANK Haus, Chicago's German American Cultural Center, and the Illinois Holocaust Museum support was gained that ultimately resulted in the CPD voting unanimously in favor of the dedication.

The rededication ceremony will take place later this year to ensure the attendance of Gertrud Kolmar's nephew Paul Chodziesner, who resides in Australia.

The other members of the Kolmar Park Rededication Committee are Daniel Egel-Weiss, Jacob Kaplan and Merry Marwig.
